- For Participants attending the exhibition, the following administration / sponsor fee/s for visa processing are chargeable :
  - 1st Representative from Exhibiting Company : EUR 40
  - 2nd Representative from Exhibiting Company : EUR 20
  - Thereafter, all subsequent Representative from Exhibiting Company will be charged at EUR 10 / pax
  - Kindly note that the above administration / sponsor fee/s will be waived in the event that this visa application has been rejected. The above fees excludes the VISA fees which is payable to the D.P.R. Korean Embassy upon collection of the visa (if approved).
- All foreigners must obtain an entry visa before proceeding to D.P.R. Korea. Exhibitors are strongly recommended to process the application latest by three months before departure from country of origin.
- This application for the list of participants shall be submitted to the organizer immediately.
- Entry visa shall be issued by the embassy of the D.P.R. Korea in the country of residence if available or the D.P.R. Korean embassy in Beijing, China.
- A visa fee of approximately EUR 20.00 - 50.00 (differs per nationality) is chargeable
- Applicant's passport is to be valid for at least 6 months.
