Dear Exhibitor,

Press reports circulating since about three weeks have created the impression of yet another international crisis being just around the corner. This latest development could not have been published at a more inopportune time, since a number of potential key exhibitors, especially from South Korea, held back their final confirmation to participate. As a result, we were no longer able to keep the deadlines for processing applications and visa permits for those companies.

Even though presently registered exhibitors already took up quite a sizeable space, we consider the participation of those hesitating to not only boost the event overall, but also benefit the other international exhibitors. After all, we want the upcoming event to be as impressive as possible, showcasing to North Korean officials and industries the wide variety and outstanding quality of products the world has to offer.

We have therefore decided, jointly with our partners in the DPRK (Korea International Exhibition Corporation), to reschedule Pyongyang ITIE to 2007 (tentatively scheduled for March).

In the following weeks, we will announce the new dates and provide you a copy of the presently registered companies. We are happy to note that majority of the exhibitors will continue to support our re-scheduled event.

We deeply regret any inconveniences this may cause, but hope that your interest in this important trade show, along with the commitment you have been showing, will remain strong. Unless you notify us otherwise, we will use your exhibitor data presently on record for the upcoming event next year.
